Despite the adjustments for the titlepage, the paper size and the margins, the default settings of the scrartcl-class can be used. For convenience a titlepage including some basic settings as a .tex-file is provided for download.

For those students using other word processors, the following rules apply:

Paper Size: DIN A4

Margins: 2,5 cm top 2 cm bottom

4 cm left 3 cm right

Font Heading: Arial, bold Font Size Heading: 14 pt.

Font Sub-Heading: Arial, bold Font Size Sub-Hdg: 12 pt.

Spacing before Hdg.: 2 Lines Spacing after Hdg.: 1 Line

Font Text: Times, regular

Font Size Text: 12 pt.

Font Size Footnotes: 8 pt.

Line Spacing: 1,5

Formatting: Justification

Page numbering: Arabic numerals centred on the bottom of each page, starting with 1 on

the first page of the main body of the text.
